


PRESIDENT'S **MESSAGE**

ON THEIR WAY UP I've heard it many times before: "I'm not interested in local



Over time, however, I've come to realize the importance of local elections on our "big issue" debates. There are several good reasons to pay attention to local politics, and to actively engage in support of Democratic candidates and policies. Today I'll focus on the importance of grooming candidates who are prepared to move up to higher office.

One key point that I remember former CDC Present Henry Vandermeir making over and over again was the importance of identifying and grooming Democratic candidates for supposedly nonpartisan local elections. Because, as Henry pointed out, most Republicans these days see everything as partisan, and will vote all the way down the ticket for the Republican in any race. Democrats, who are often more cerebral in how we approach issues and candidates, often hesitate to vote for someone whom they are not familiar with "just because they are a Democrat." Coupled with our lower election turnouts, the result is that many cities that reliably vote Democratic in Gubernatorial and Presidential elections have school boards, city councils, and other local offices that are heavily weighted towards Republicans. Then, when higher offices open up, we have

The same argument can be made regarding voting for female and minority candidates. That is why groups like Emily's List and The New American Leaders Project have turned their attention to nurturing more local candidates and assisting them with the campaign learning curve. Today, in 2015, only 27% of the California legislature is female, just above the national average of 24%! If we ever want our legislature to start looking more like our populace, we need to start giving Democratic women and minority candidates the benefit of the doubt, supporting them even if they are not yet "proven." If we don't give them the opportunity to prove themselves, who will?

In closing, I encourage you to vote, and ask your neighbors to vote, for the following BCD endorsed candidates in the upcoming March 3 election:

- Candace Nafissi, Redondo Beach City Council (the only Democratic candidate!);

Robert Kennedy, Jr., and my friend of almost 40 years, Ed Begley, Jr., were in Hermosa Beach last night, at our Hermosa Beach Community Theatre.



Invited by Hermosa Beach Mayor proTem and Beach Cities Democrats member Nanette Barragan, they came and spoke, along with an amazing panel of environmental organization leaders, about the environmental impacts of oil drilling in general, and more specifically about oil drilling in Hermosa Beach, an issue that will be decided by the citizens of Hermosa Beach in a special election on March 3.

Just when you think you've heard all that could be said about oil, oil drilling, oil companies and the environment, last night Bobby Kennedy captivated us all with a history lesson about humanity's relationship with our planet, beginning with the legal code of the Roman Emperor Justinian, on which much of modern law is based. Under that code, all Roman citizens, meaning free men, were understood to have a sacred right to share in the bounty of the Earth's pleasures and produce. Over time, that sacred right has been taken away from us, "land grabbed" by feudal lords and wealthy land barons. This was the historical conflict underlying the stories of Robin Hood and Prince John. It continues to be waged against us by the Koch Brothers, alluded to by Kennedy as the feudal lords of the 20th & 21st centuries.

As I have often repeated in these pages, my own history as an environmentalist began on April 22, 1970, the first "Earth Day," when as Senior Class President of my high school I followed the directive of my then San Francisco Bay Area Congressman and environmental hero, Pete McCloskey, and organized my school's Earth Day activities. The objective of that day was then, as now, to

heighten the awareness of "Ecology" and of our relationship with the planet and its resources, rapidly being depleted by overpopulation and overconsumption which threaten the quality of life on the planet.

Today, a growing mountain of solid scientific data tells us ever more insistently that this irresponsible behavior is the major contributor to "Climate Change." The situation has reached crisis stage, already producing increased storm intensity, sea level rise and widespread drought, to name just a few of the consequences. But in addition to that, as Bobby Kennedy drew our attention to last night, is the huge element of economic injustice in this continued bad behavior regarding the Earth.

As in the days of the feudal lords, modern-day wealthy barons have influenced politics and government to favor the status quo, supporting fossil fuel producers and related industries through outrageous subsidies while making it more and more difficult for the rest of us to harvest the clean, healthy, safe ener-

gies from the sun, the wind and the tides. And while hundreds of thousands of miles of pipeline to move the polluters' products have been authorized and financed by governments and investors, only minimal attention and money have been invested in transmission lines and infrastructure needed to carry the clean power from the rooftops of the 99% of the rest of us.

Bobby made it clear last night that this fight in our town, this line in the sand that can be drawn on March 3, is about so much more than just Hermosa Beach. Yes, it is ridiculous to even consider this project here in tiny, densely populated Hermosa given the inevitable impact on our quality of life. Yes, oil drilling would threaten the economic engine that is our beautiful beach and our clean, inviting community. But beyond those reasons for voting against the measure is that an overwhelming victory for "NO on Measure O" will send a message to the region, the state and even the nation, that the people say NO! to old, dirty, selfish energy, and are moving to the clean, sustainable, and job-producing energies of the future.
