Important Notice 2016 Democratic State Convention

The annual California Democratic Party (CDP) State Convention will be held in San Jose, at the San Jose Convention Center, from Friday, February 26 to Sunday the 28th. Those of you planning to attend can find all the information you need on the CDP website at: www.cadem.org/convention.

Delegates to the Convention include our Los Angeles Democratic County Committee members, elected Democrats and their proxies, and the Democrats who were elected at our 66th Assembly District caucus at the end of January. PRESIDENT'S MESSAGE

A Tale of Two Nations I was struck this week by a sharp contrast between two news stories I read.



In one, I was reminded that in April California will make birth control pills available to women through pharmacies without a prescription. (LA Times 2/14/16, "Birth control pills without prescriptions, coming soon to California under new law"). This is expected to improve access to birth control and reduce unwanted pregnancies. Yippee! What's not to love about that?

On the other hand, researchers from the University of Texas at Austin just reported in the New England Journal of Medicine that there was a sharp, immediate uptick in pregnancies in counties where Planned Parenthood clinics had closed since the Texas state legislature radically reduced funding to family planning clinics in 2011. In just 18 months since the cuts, the researchers calculated that the relative increase in births was 27% for women who lost access to subsidized family planning services. "Many of these births were probably unplanned, since the increase was only seen in counties where women faced new hurdles in access to contraception." (LA Times 2/3/16, "After Texas stopped funding Planned Parenthood, low-income women had more babies"). This shouldn't come as a big surprise: the Texas Observer reported shortly after the cuts that "the bipartisan Legislative Budget Board estimated that last year's cuts would lead to more than 250,000 women losing services and 20,000 additional births covered by Medicaid" (the actual number of women who eventually lost services was much higher). (Texas Observer, 8/15/12, "One Year Later, Cuts to Women's Health Have Hurt More Than Just Planned Parenthood").

These additional, unplanned, unwanted births to Medicaid recipients will be especially costly to the state, since Texas refused to accept expanded

Medicaid funding through the Affordable Care Act (Obamacare). As a result, they are losing approximately \$10 billion a year in funding that would otherwise reimburse their hospitals for uninsured care. In short, the costs of their ideological warfare on the poor, women and Obama are finally coming home to roost. NPR reports that "Texas has the secondhighest health insurance premiums in the country, right behind Florida. And Texas has the third-highest property taxes in the country. In Dallas, for example, more than half of property owners' county property tax bill goes to reimburse Parkland Hospital for the uncompensated care it has to provide." (See NPR.org, 5/30/15, "Texas Politicians And Businesses Feud Over Medicaid Expansion"). In short, Texas' elite are beginning to realize that it's very costly to eliminate family planning and turn away federal money to subsidize universal healthcare. Which would almost provide us California progressives with a moment of schadenfreude-almost, that is, if it weren't for the heartbreaking toll that unwanted pregnancies take on those women, their children, and our society.

Access to free or highly affordable birth control is the type of issue that both conservatives and liberals should be able to agree on. It's good social policy, and it has a very high financial return on investment. Yet in our highly polarized political environment, we are creating a splintered nation of have-and-have-nots that goes well beyond wages and wealth to encompass healthcare, voting rights, civil liberties-every aspect of life, liberty and the pursuit of happiness. The good news, from a social science perspective, is that I think this will provide us with ample data as to who is right about how best to uplift our nation and its people. Progressives can increasingly demonstrate in objective economic terms that universal healthcare, a living wage, LGBT rights, women's rights, and investment in education are the winning formula for moving our nation forward. The conservative movement will continue to prove itself to be outdated and irrelevant. Sadly, so much human suffering will ensue in the course of this particular experiment that I can only hope that it comes to an end very soon. Best.

Development in Redondo Beach

Redondo Beach City Councilman Bill Brand discussed over-development near the ocean in Redondo Beach. He began by talking about the Harbor Drive AES power plant and the need for a referendum to rezone the area on which it is built. He then moved on to talking about development on the waterfront, involving a public-private partnership between Redondo Beach and CenterCal that would double the development around the pier.

The project had a flawed Environmental Impact Report, no feasibility studies and results-driven traffic circulation analysis. The EIR goes to the Harbor Commission in the spring. **Resolution on Charles Lester**

Jeff DuClos discussed the California Coastal Commission's attempts to remove Executive Director Charles Lester. He expressed concern over the Coastal Commission's growing number of lobbyists and developers, who are now attempting to oust Lester. Although Lester has had an excellent record as executive director, these commissioners still asked him to resign without giving any reason. Lester asked for a public hearing regarding his dismissal.

President Campbell presented a resolution opposing attempts to remove Lester. Bill Brand made a motion to pass the resolution, which carried unanimously. <u>Torrance Refinery Update</u>

Connie Sullivan discussed safety concerns surrounding the Torrance refinery. After an explosion in the refinery last year nearly hit a tank storing hydrofluoric acid, concerns arose over the possibility of a disaster involving the leakage of hydrofluoric acid and its deadly vapor, which could spread over 3.2 miles and potentially endanger a quarter million people. Ted Lieu is working on measures to prevent hydrofluoric acids, and State Senator Ben Allen has a greater chance of passing legislation regulating its use due to the party composition of California's senate.

The Court

I was going to write a column about the campaign between Hillary and Bernie, and what makes up real change ("Change We Can Believe In"). I was also thinking of writing a piece about how Donald Trump is the Republican's Frankenstein, the monster they created but can no longer control. I also had a really wonky piece about how the Federal Reserve's interest rate hike last month was really a vote of no confidence in Congress, generally, and specifically the Republican leadership of Congress.

But none of that matters anymore.

As I was writing, it was announced that Supreme Court Justice Antonin Scalia passed away. While all condolences are appropriate and are extended, the political implications of this are impossible to overstate. Anything that was going to be considered in the United States Congress has changed dramatically, as has the tenor of the Presidential campaign.

Since 1972, the Supreme Court has had a majority appointed by Republican Presidents. That has had dramatic implications for the court and the country. The reinstatement of the Death Penalty, the narrowing of civil rights that had been extended during the Warren Court, the effect on Federalism with both the Commerce Clause and the 11th Amendment, campaign finance, and of course *Bush v. Gore.* My Law School note adopted the premise that the Court had become such a political body that a virtual tie election is naturally decided by the Court, because it was merely a reflection of the long term politics of the nation. So what comes next means three big things:

First-Every Democrat, every legal scholar and judge, every law enforcement official, and every patriot who believes in the progress of democracy, must put a full court push on the Senate to confirm President Obama's nomination. Certain Republicans, who have spent 7 years trying to undermine the Obama Presidency, are already pushing to stall the nomination until a new President takes office. That is nearly more than a year away, and would be unprecedented in American history. Stalling this nomination is a dereliction of duty, and an effort to undermine the basic foundation our Constitution. Barack Obama was electedtwice-to a four year term, and should, and must, be given every right and consideration. There is no need to wait until the next President takes office-this is not in the lame duck days of the Administration. And more importantly, leaving a vacancy on the Court for a year would undermine the administration of justice. It literally has never happened before, and should not be allowed to happen now.

Second—President Obama must quickly move to nominate a justice whose record is unimpeachable. The reality, for better or worse, is that appointing a liberal lion to replace Scalia will be nearly impossible, so we should not expect to see a Brennan or Ginsberg. But even a moderate like a Breyer or Souter would

(Court, continued from page 3) be a welcome change from Scalia's consistent, but still wrong-headed conservatism. Some early guesses include Sri Srinivasin, an Obama appointee unanimously confirmed to the DC Circuit in 2013; Albert Diaz, a native of Puerto Rico and Marine veteran, unanimously confirmed in 2010 to the Fourth Circuit, and Jeh Johnson confirmed by a vote of 78-16 to be Secretary of Homeland Security, and previously a prosecutor and distinguished lawyer.

Third—the Democratic Primary must be about our very best chance to win in November. Nothing else matters. If the Republicans are successful in holding up the President's nomination, a Democratic President must be the one to replace Scalia. It simply cannot be left to Ted Cruz or Donald Trump. Whatever you felt about the election before, that has changed. If you are concerned about corporate money in politics, Wall Street, Health Care, workers' rights, and women's rights, then you must look only for the person that has the best chance of winning in November.
