After calling the meeting to order, President Bobbi welcomed new members and greeted our elected officials and representatives.

Vice-President Dency Nelson announced that our building, the Hermosa Beach Community Center, now has photovoltaic cells on the roof, thanks in large measure to the efforts of Hermosa Beach Mayor Justin Massey. He also reported on Senate Bill 562, single-payer health care, which BCD endorsed last month. The Bill is still in committee, and Senator Ben Allen says it needs some additional fixing to get it right.

Reports from Elected Officials

Ted Lieu's Office

Joey Apodaca from Ted Lieu's office

reported on the following: Foreign Affairs

The Congressman is concerned about President Trump's apparent threats against the Assad Regime in Syria. Although there are rumors that President Assad plans to use chemical weapons, the laws of war state that it is illegal to proactively attack a sovereign nation that has not attacked the United States. Lieu has subpoenaed the Administration to obtain a copy of their Middle East policy. *Opposing Trump* 

- Also a matter of concern is that Jared Kushner, the president's sonin-law, has met with Russian Ambassador Sergey Kislyak to set up a back channel of communication. Kushner lied about this fact on his security clearance form. Lieu is calling for Kushner's resignation, and to have his security clearance revoked.
- Withdrawing the U.S. from the Paris Climate Accord was a tragic decision that has relinquished American leadership on climate change.
- Lieu has also joined in a suit against the Administration for violating the emoluments clause.

There was good news about the VA; they have now completed over fifty permanent housing units for veterans on the West LA campus, with plans for over 2,000 units in total. This is the VA's first permanent housing in 130 years. However, the VA is conducting cruel and unethical experimentation on dogs at the LA medical center, which Rep. Lieu has protested in a letter.

# Infrastructure

The Congressional Progressive Caucus has proposed \$4.6 trillion to fix our nation's infrastructure problems. Joey has been promoted to Senior Field Representative. Congratulations!

#### Al Muratsuchi's Office Torrance Refinery

Senior Field Rep. Andrew deBlock spoke about the Community Refinery Plan, and Assembly bill 1645, which would limit and eventually ban the use of Hydrofluoric Acid. Those who want to get involved in a working group on the Air Quality Management Board should contact Andrew.

## Budget

Andrew proudly announced that the Assembly has passed its budget on time, with increases in education and arts funding, and larger reserves.

There were to be community hearings on the US Air Force base in El Segundo.

## Justin Massey

The Hermosa Beach Mayor reported that the city's fire services have been contracted out to the LA County Fire Department, a plan that will be complete in 2018. Upcoming meetings on PLAN Hermosa. This Plan will set a long-term vision and provide policy direction to residents, city staff, decision-makers, and the community on what investments are to be made in infrastructure. Particularly important is preserving the city's small town character and historic buildings. Two major projects include the Skechers Design Center, and a tract called Lazy Acres, owned by Bristol Farms, to be opened in 2018. There is a draft EIR available for the Skechers plan, which lies in the two adjacent cities

of Manhattan and Hermosa Beach.

The City Council has adopted a budget which calls for more solar panels, extra restrooms at Clark Field, South Park renovations, and further implementation of the bicycle master plan.

### Christian Horvath Measure M

On the Redondo Beach City Council, guidelines have been drawn up for Measure M, which affects transportation. The recent reconfiguration of Vista del Mar, limiting the roadway to one lane in each direction and adding bike lanes, is controversial since it slows traffic on that busily traveled route. Horvath said "road diets" are a good idea, but this one has caused massive traffic jams, and the city is working with Councilmember Mike Bonin.

### Measure H

This measure on homelessness, passed last year, involves working with local police and an organization called PATH, People Assisting the Homeless.

#### Other Business

Massey said the city would fight to keep the military base open if the government threatens to close it under BRAC (Base Realignment Closure).

**SB 649**, the Small Cell Bill, would upgrade the grid to 5G technology, but the city wants to have a say in where the equipment will be located.

SB 35, regional housing allocation numbers. This bill acknowledges the rising costs of real estate and rentals in the beach cities due to more people moving in. It would streamline the approval process for affordable housing. SB 268 would change the makeup of the LA County Metro Board, allowing in other cities outside of Metropolitan LA. *Community Choice Aggregation:* Horvath reported that South Pasadena, Rolling Hills, and Calabasas have already signed on (see June issue of BCD).

### Measure C

This legislation, approved by the voters, is now under discussion. Horvath would like to hear more from the California Coastal Commission.

Also representing the Redondo Beach City Council, Gran announced that the budget has been passed, which will allow funding for improvements to the Artesia corridor, including storefront improvements. Plans to revamp the South Bay Galleria are in the works but delayed. There is a plan to bring the Green Line to Torrance by 2025, with the goal of easing traffic congestion.

#### **Officer Elections**

We presented the slate of BCD officers that was announced last meeting: President: Bobbi Buescher Vice-President: Dency Nelson Secretary: Ryley Simcox Treasurer: Edna Murphy The slate was voted on and passed unanimously.

### Featured Program

Tony Hale showed a video called "The Future of Work in America" which focuses on how we can create a new economy when the classic idea of work no longer exists. Automation is replacing jobs throughout the country, even jobs we never imagined could be done by anything other than a human being. Retraining will not solve the problem. Even in such professions as doctors and lawyers--eventually robots will "know" more, and will be able to absorb learning much faster than people. Even writing novels: a smart robot can absorb thousands of books, learn what makes a good novel, and replace human authors. "Humans Need Not Apply."

The world is changing rapidly around us, and we need to be prepared.

The solution? A Universal Basic Income, a concept that's getting a lot of attention, especially in Silicon Valley. Mark Zuckerberg talked about it in his commencement address to Harvard. A country that has universal basic income guarantees every person a set minimum income regardless of criteria -- age, wealth, job status, hometown, family size, etc.

Allocating a guaranteed income would end poverty, allow people to work at a job that enhances their life and live wherever they like. Canada and Finland have begun experimenting with this as is the state of Alaska and some Indian reservations. In those places, hospital visits are down, students do better in school, and people still find productive activity.

#### Other Business

We discussed the California Values Act, SB 54, which would ensure that state and local law enforcement resources are not used to arrest immigrants. It would also help local immigrants feel comfortable speaking to local authorities without fear of deportation. Because we had not previously announced endorsing this measure, it was moved and passed that we table the vote until next month's meeting.

It was announced that Carolyn Waters and Kanji Sahara have been voted as Democrats of the Year. They will be honored at the upcoming FDR dinner. Congratulations to them both!
