Global Warming is Here Now and is Endangering our Planet

On September 7, the Reuters News Agency published a most alarming prediction. Professor Mike Pilling, who teaches Physical Chemistry at Leeds University in Northern England, told reporters that millions of people across the globe are set to die early due to extreme weather events such as heat waves and floods from heavy rainfall caused by global warming. . He stated that, "There are predictions of a ten-fold increase in heat waves. . The biggest issue is climate change. We have got to control it."

In California, because of a law passed by the state legislature under Gray Davis, the state Air Resources Board is formulating regulations to achieve the "maximum feasible and cost effective reduction" of global warming pollution from motor vehicles. September Recap

Campaigns Heat Up

Bobbi opened the crowded meeting with rave reviews of the Democratic Convention. She described rousing addresses from our candidates, especially John Kerry; he "gave us back our country." President Carter was direct and candid and "told it like it was," Barack Obama was inspiring.

Next, Shirlee Browne reported that we have over \$5,000 in the treasury as a result of our explosive growth in membership. Most of the new members were recruited by PZ Associates.

Our first candidate to speak was Donna Groman, running for Superior Court judge. She told of her years of experience working with juveniles and families and says she would take a leadership role in the court and bring stability to family court cases.

Her experience includes seven years as a commissioner with experience in mental health treatment, domestic violence, and child abuse.

Judges' races are county-wide and nonpartisan. Asked about her position on certain issues, Groman said the rules of judicial ethics prevent candidates from expressing opinions about matters that may come before them. Voters can check on the Internet to learn about their positions; check the League of Women Voters and SmartVoter.com. Groman's opponent is a Republican deputy district attorney.



Judicial races are expensive and it costs \$31,500 to place a statement in the voter pamphlet.

Next we heard from Mildred (Millie) Escobedo, running for Superior Court Judge Office 18. She has been a Superior Court Referee since 1998 and is endorsed by Sheriff Lee Baca, State Assemblyman Marco Firebaugh, and the Mexican American Correctional Officers Assn. She is the only Latina and the only Democrat in her race.

We voted to endorse Groman and Escobeda and donate \$250 to each of their campaigns.

Lillian Light then spoke about the upcoming event "Earth, Environment, Economics, Election," which BCDC is co-sponsoring this month, featuring environmentalist John Quigley. The club voted to donate \$100 towards mailing expenses.

Precinct organizers Lori Geittmann and Jim Aldinger reported that the August 21 organizing event at Polly-



wog Park was a huge success with 120 people showing up. Volunteers were asked to walk their own precincts or a neighboring one to recruit more volunteers and get people to vote by mail.

Lori said that being a precinct captain allows one to participate in the "ultimate local political process." She said most people don't know who to vote for in the local races and seek out their precinct captain for advice.

District leaders include Anne Faas, Shirlee Browne, Tony Hale, Lee Fink,

Mustapha Sesay, Ray Waters and Dency Nelson. Lead organizer Larry Fox has been working night and day printing out precinct forms.

Lori reminded us that local elections are coming up in March. Jim Aldinger will be running again for Manhattan Beach City Council, Lee Fink may run in Redondo Beach, and Councilman Kurt Schmalz may run for Mayor.

Sandra Lloyd Jones from Mike Gordon's campaign thanked those who have been helping with phones. She said although Mike is currently ahead 43% to 37%, his could still be a close race. His opponent Greg Hill is running a negative campaign, portray-

ing Mike as a tax-and-spend liberal. (Ed. Note—Don't people ever tire of this line?) She said—quoting Bill Clinton—that if Republicans fought fair, they would never win.



Bobbi reported that CDC is entering into a contract to acquire the Cali-

fornia Voter File for all 58 counties in the state. When completed, the file will be accessible to all CDC affiliated organizations from their home computers. The data will include walk sheets, telephone lists, mailing lists and targeting information. The project is expected to cost \$200,000 at startup and \$60,000 per year thereafter. Our local CDC has pledged to raise \$25,000. The club voted to donate \$250.

It was reported that George Nakano is sponsoring two bills: AB 2065, to require care facilities with six beds or more to install sprinklers, and AB 2093 to prevent gray water from being dumped into California waters. We were sad to hear that this is George's last week in session. He is considering a run for State senate in 2006.

Alexis Beeman announced a new State Democratic Party office has opened in Inglewood on Imperial and Yukon. The Party is opening offices in areas with low voter turnout to encourage volunteers. The Inglewood office has twelve phone lines and has organized precinct walking seven days a week. Hours are 10 to 9 M-F, 10 to 6 on Saturday, and 2 to 6 on Sunday.
