True Reform in the Secretary of State's Office

BY SENATOR DEBRA BOWEN There are few things more important in a democracy than the integrity of our electoral process.

That's why it's so important for California's Secretary of State—the one person responsible for certifying election results for all state and federal offices in California, as well as all of the statewide ballot propositions—to conduct the duties of the office in a nonpartisan fashion.

The first step toward meeting that goal is to pass conflict of interest laws that prevent the Secretary of State from endorsing or campaigning for candidates whose electoral results he or she is responsible for certifying. The Secretary shouldn't be co-chairing a presidential campaign and thanking donors for contributing to a particular candidate, which happened in Ohio in 2004, or chairing a presidential campaign while simultaneously ordering state elections boards to stop hand counting ballots, which happened in Florida in 2000.

A second important reform would be to preclude the Secretary of State and candidates for the office from accepting campaign contributions from voting equipment manufacturers and vendors whose systems he or she is charged with certifying for use in California. The 2002 passage of the Help America Vote Act (HAVA) created a new political player in the electronic voting machine manufacturers who are vying to get their voting systems installed in polling places throughout the country. Since the enactment of HAVA, the four major electronic voting machine manufacturers have given more than \$652,000 to candidates running for office, including Secretary of State candidates in four states.

Simply eliminating the party label next to the Secretary of State's name won't prevent him or her from getting involved in campaigns in a way that leads voters to question the Secretary's impartiality. That's because it doesn't reduce or eliminate the inherent conflict of interest between the Secretary's responsibility to ensure elections are conducted in a fair and nonpartisan manner, and partisan activities, such as supporting a candidate whose very election the Secretary of State will certify.

To minimize that conflict and instill confidence in voters that the Secretary is focused solely on the integrity of the electoral process, we need reforms that will change the very nature of how a Secretary of State is allowed to operate while in office. That means doing more than the political equivalent of the sole of the sole

February Recap

Gov is Vulnerable

Speaking to our February attendees, Senator Debra Bowen said that Arnold Schwartzenegger's popularity is starting to erode. The Democrats who first supported him did not intend to start a war with teachers or jeopardize the police and firefighter force in our state. But the govemor's ability to command the media and send out paid signature gatherers—who receive up to \$12 per signature—has changed the political landscape in California and launched a historic battle for our future.

With his star power, Schwartzenegger is pushing for measures that would have gone nowhere under another administration. He is threatening to hold a special election to let voters decide on merit pay for teachers, privatization of pensions, and changing the rules of redistricting.

What's wrong with merit pay? It

The candidates

RB Mayoral candidate Kurt Schmalz gave an update on campaign events and said he had been endorsed by the police and firefighters. He thanked BCDC for our endorsement.

Lee Fink read from a flyer put out by the South Bay Republicans mentioning BCDC and saying they feared that the Democrats had a plan to take over the city council. Lee has also been endorsed by the police and firefighters.

Two of the candidates for city attorney spoke: Steve Colin encouraged people to use and promote absentee ballots, the safest way to get your vote counted. Dave Wiggins predicted a large turnout in his district over the open space issue.

We also heard from Drew Gamet, a teacher running for Redondo Beach school board. Gamet says he has the support may seem like a good idea, but exactly who gets to decide what constitutes merit? Four members of the State Teachers Retirement System who opposed the idea—people who were appointed by Schwartzenegger—have seen those appointments rescinded.

Bowen has recently introduced bills in favor of fairer elections. SB 469 would require signature gatherers to tell people whether they are being paid and by whom. Meanwhile, the Governor has gone to court to sue the Fair Political Practices Commission that keeps him from raising unlimited funds to support ballot initiatives.

She has also introduced SB 1050 to prevent a repeat of the San Diego ballot controversy (called "Bubblegate"), in which over 5,000 votes for write-in candidate Donna Frye were not counted because voters didn't darken the oval next to the write-in line. Her bill would require votes to be counted as long as the voter's intent could be

of his fellow teachers and thanked us for our endorsement.

Todd Loewenstein reminded us that he is running on a partnership program to include teachers, administration, and the school board. He said the Daily Breeze and Easy Reader have run stories saying that the superintendent appears to be involved in electioneering, which is against the education code.

determined.

Electronic voting is under discussion, most recently due to the close gubernatorial election in Washington State. In that race, Democrat Christine

Gregoire appeared to lose by 200 votes on election day. But in the recount, a tray of uncounted ballots was discovered, awarding her the governor's seat. This would have been impossible had the voting been 100% electronic.

Bowen said a bill is also in the works to allow instant runoff voting, which ranks votes and eliminates the need for runoff elections.

The Manhattan Beach candidates were participating in a forum and could not be present. Bobbi read a letter from city council candidate Eric Mah apologizing for sending out a "No Solicitors" campaign door hanger. Some people feared this message would hurt our precinct walking effort.

It was reported that PZ Associates is again canvassing in Redondo Beach to draw more members to the club and help our candidates.



The Senator plans to run for Secretary of State in 2006. There is a move to turn this into a nonpartisan office, but she believes that would keep voters from holding people accountable. Instead, she favors prohibiting the officeholder from certain activities that lead to a conflict of interest such as certifying the vote count ("who can forget Katherine Harris?").

The Governor's plan for redistricting bears an eerie similarity to what happened in Texas. He proposes to "randomly" appoint a panel of retired judges. Republicans who favored redistricting in the past were voted out of office as overly partisan.

Assemblyman Alan Lowenthal is working on an alternate bill that would prevent one party from dominating by creating a redistricting commission made up of appointees of the governor, the senate pro tem, and the Speaker.

Mustapha reported from the 53rd AD Committee that they cannot give money to the club but can donate to endorsed candidates.

A few days ago I received a note from a good friend, a Republican who believes in self-reliance,
