From the **President**

of Iraq



I wrote this column, the President spoke to the nation about the War in Iraq. It was a surreal event—a terribly unpopular President urging the American people to not only support continuing to fight a war which they had clearly and overwhelmingly voted against, but to actually escalate the fighting, rather than bringing the troops home. The 2006 Congressional election resulted in the largest national election victory (and only clear electoral mandate) since Bill Clinton won re-election by a landslide in 1996. Yet Bush has managed to completely ignore the will of the voters.

The Democratic Congress must oppose these efforts. The Democrats in Congress are universally opposed to this, and 70% of the American people are firmly with them. They need to be clear and unambiguous. At the same time, we will have to be patient with our leaders in Congress. While too many of them were too timid in opposing this ill-fated misadventure in the run-up to war in 2002 and 2003, even as the new majority party in Congress, Democrats will be limited in our ability to stop the President. Congress can pass legislation requiring the President to redeploy the troops, but even if it were to withstand the constitutional muster of separation of powers, it would surely be vetoed, and our

majority in both houses is still too thin to override a veto on that measure. Similarly, legislation could be passed denying funding for the Bush/McCain Escalation, but it would likely be subject to a veto and not overridden. Additionally, while a number of Republicans are starting to come around, others in the Senate are threatening to filibuster our efforts.

While it is clear that Bush will not listen to the American public, we must continue to build our case that the Bush/McCain Escalation is what Republican Chuck Hagel has called "the most dangerous foreign policy blunder carried out since Vietnam." We will have to build and keep public opinion strong enough that Republicans realize that continuing to support this folly will end their political careers, and banish their party to a permanent minority. This will take time, effort, and patience on our part. We must expect our members of Congress to be aggressive—to hold oversight hearings, to speak out forcefully for their beliefs, and to put forward legislation that can pass which reigns in the administration, and do the best that they can to end this senseless war. We must help them: by supporting them when they are strong, prodding them when they are not, but also by understanding that Congress cannot end the war on its own. Our success in 2006 has only gotten us halfway—and despite the best efforts of our leaders in Congress, it may not be until we elect a Democratic Commander-in-Chief that we can finally get American troops out

And if that's what it takes—let's elect a Democratic President in 2008!

November Recap

Sweet Victory

Democrats this month celebrated our great victories in the November election, sending our own Senator Debra Bowen to the California Secretary of State's office, taking back the majority in the US Senate, and making Nancy Pelosi the first woman Speaker of the House of Representatives in American history.

With the election behind us, we took some time to put this election in light from an academic perspective. PI Gagejena, an adjunct political science professor at El Camino College and a local Democratic activist, shared some of the ideas and numbers that he has presented to his class. The most striking thing about the election was the overwhelming way in which the Democrats won throughout all the demographic groups. Democrats increased their share of the women vote by 7%, the Asian vote by 9%, and the Latino vote by 30% nationwide. Even more impressively, Democrats won a majority of the male vote, increasing their vote share by 7%.

The 2006 Election was another big success for women in America. In addition to Speaker Pelosi, there is now a record high 16 women in the Senate. PJ discussed some of the causes. The Abramoff and Foley scandals played a big part. And the war was critical, and led to Rumsfeld's resignation the next day.

Ray Waters reported that the County Committee is considering increasing the Club chartering fee to \$100 from \$30. Also announced was that the 53rd AD would hold its biannual caucus on January 13, 2007 to elect delegates to the state convention.

Tony Hale reported from the Democratic Action Center. He mentioned the success of students who participated in the election from Mira Costa, Redondo Union, and San Pedro High Schools. Students at Mira Costa

and Redondo will be forming Democratic clubs, which we should support and foster. Overall, the DAC made more than 8000 calls, identified 1000 Democrats who were called on election day to get out to vote. Tony also reported from the Palos Verdes Democratic Club that he was reelected President and Barbara Farren was re-elected Vice President.

Environmental Update

Lillian Light reports that our beach cities are taking local action against global warming. Last November, Hermosa Beach Mayor Sam Edgerton signed on to a resolution endorsing the climate protection agreement—equivalent to the Kyoto Protocol—that the Beach Reporter described as follows: "The city will make energy efficiency a priority by 'building code improvements,' using 'energy-efficient lighting' in city facilities, increasing recycling rates, purchasing 'Energy Star' equipment and appliances, and promoting and adopting 'green policies.""

The Manhattan Beach City Council placed the issue on their January 16 agenda and members of several environmental groups were expected to attend the meeting.

Our federal government is taking action too: Rep. Henry Waxman (D-CA) has introduced the Safe Climate Act (H.R. 5642) to limit US global warming emissions, and Senator Jim Jeffords (I-VT) has proposed the Global Warming Pollution Reduction Act (S. 3698) to cut emissions by 2% each year between 2010 and 2020.
