January Recap

Candidates, Green Cities

Ray opened the meeting with a litany of the reasons for celebrating President Obama's first few weeks in office: He will close Guantánamo, leave Iraq, outlaw torture, allow stem cell research, and reopen participation in treaties, to name just a few pledges.

Our program had changed: Instead of Paul Arney from Jane Harman's office,

we heard from several speakers on issues ranging from the environment to local elections.

Our first speaker was Kathleen Jacecko from Teaching Green (see front page). Next we heard from Louise Fleming on solar energy and Redondo Beach's joining the Cool Cities movement. A Cool City is one that has made a commitment to stopping global warming by signing the U.S. Mayors' Climate Protection Agreement. Tory Erickson Begun in 2005, the

Fleming has been talking to Councilman Steve Diels on solar and renewable energy projects in Redondo Beach. She is affiliated with California's Green Workforce Coalition, a partnership that provides local businesses with information about sustainability, climate change legislation, and green jobs.

Toni Alario presented an open letter written by the Citizens Trade Campaign (CTC) on rebalancing NAFTA and

CAFTA. It refers to Senator Sherrod Brown and Congressman Mike Michaud's Trade Reform act, SB 3083 and HR 6180, respectively. The bills would put pressure on China to devalue its currency and halt the Doha talks by the World Trade Organization that they claim weaken domestic trade laws.

After some discussion about whether to endorse this open letter, the club asked Ray to form a committee on the issue to report back at the next meeting with a recommendation.

Toni also passed out a list of candidates who have taken out filing papers for state office. It was noted that in some cases, a Democrat may appear to be challenging a popular incumbent Democrat: Sheila Kuehl has filed for Secretary of State Debra Bowen's office. Candidates may file in order to keep their political action committees going and later change or revoke their

raised all other candidates in the South Bay and has conducted misleading push polling against Erickson.

Erickson has twelve years of federal and state trial court experience and has been an active community volunteer. He has served on the board of the Jenesse Center, a large domestic violence intervention program; as a resource specialist with the LA Unified School District; and as a youth basketball coach with the Torrance YMCA. The club voted to endorse Erickson and contribute \$200 to his race.

Next, we heard from Diane Cagle, running for Redondo Beach City

Council in District 2. She is a lifelong Democrat and the daughter of a union organizer. She is employed as a speech pathologist with the Torrance Unified School District and has served on the board of the Redondo Beach Art Group. Her husband, Chris Cagle, is a councilman in District 2.

Also running for the seat is Bill Brand, who spoke next. He became involved in Redondo Beach issues when the City Council approved the "Heart of the City" plan in 2002 which called for 3,000 condos on the AES power plant site. He opposed this development plan and helped gather signatures for the two referendums it took to stop it. He has been endorsed by Assemblyman Ted Lieu and by Jim Light, president of South Bay Parkland Conservancy.

The club voted by secret ballot to determine which of the two candidates

to endorse, but lacking a 60% majority, we did not endorse either candidate.

Larry Fox next spoke on the VAN (Voter Activation Network) software system for grassroots organizing. He would like to see committed volunteers who are willing to walk precincts and make phone calls, and would be willing to deploy the system if there are enough committed members.

Finally, the club is still looking for a new place to meet since the Hayward Center will not be available after January. We may also change our regular meeting night from fourth Tuesdays to fourth Thursdays.
