BEACH CITIES GREEN

This month, my focus in this column will be California Assembly Bill 920 (Huffman), which has just made its way to the Senate floor. AB 920 has as one of its co-authors our own Assemblyman Ted Lieu.

Before going into detail about AB 920, let me take a couple of steps back to explain its importance. I can't imagine that there is anyone reading this column who doesn't understand the benefits of greening our electric grid and moving us away from the burning of fossil fuels and dangerous nuclear power generation. The opportunity for each of us to turn our rooftops into clean, green power generators has been available for over a decade now through the California Solar Initiative and what are known as grid-tied, net-metered, photovoltaic solar panels. Many of us have taken advantage of this initiative, including BCDC President Ray Waters and yours truly. With the installation of a photovoltaic solar-energy system at our

homes, we have been able to generate enough electricity to substantially reduce our monthly electric bills while obtaining that power from a non-polluting and sustainable source, the Sun. State and federal governments have offered financial incentives to reduce the cost of installation, but one important incentive was missing until now.

Many of us have large enough systems and are so frugal in our electricity consumption that our systems produce more electricity than we consume. That extra electricity goes back out onto the grid to be sold to other customers without the owner of that rooftop generator being financially compensated. We can take pride in offering clean electricity for others to use, but up until now the law only demands that the utility companies compensate us down to "net zero." This is where AB 920 comes in.

AB 920 will demand compensation for all electricity generated by rooftop or backyard solar or wind systems. It will move us rapidly toward a truly green grid powered with local, "homegrown"

May Recap

Presiding in Ray's absence, Bobbi Buescher opened the meeting by thanking Michael Keegan for making Manhattan Bread & Bagel available for club meetings and providing those fabulous refreshments.

Our speaker was Kate Anderson, who is running for the Assembly seat that will be vacated by Ted Lieu in 2010. Anderson described herself as an eternal optimist in spite of the train wreck that is California politics, especially the current budget debacle.

Anderson began her public service career as an intern for Congressman Henry Waxman, but soon realized that a law degree would help her impact the issues she cared about. She attended the University of Chicago Law School, where she was a member of the Law Review. She clerked for Chief Judge Harry Edwards in the DC Circuit and later returned to Capitol Hill to serve as Counsel on the Government Reform and Oversight Committee for Congressman Waxman.

Her achievements included an investigation into abuses in nursing homes and a major study on the irregularities of the 2000 election. Concerned about disparities in the vote count, she observed that votes were undercounted, and more ballots thrown out, in poor and minority areas.

After her move to Los Angeles to work for the law firm of Munger, Tolles & Olsen, LLP, she became active in child care issues. In partnership with two other professional companies, she formed an employer-sponsored child care center scheduled to open in summer of 2009.

Anderson lives in Mar Vista and is a member of the Mar Vista Community Council and the Hilltop Neighbors Association. If elected, her top priorities will be to rescind the 2/3 majority in the State Legislature and reform the tax and initiative systems in California.

We were introduced to Rebecca Kim, a new field representative for Jane

Harman, by Harman representative Jessica Duboff. Kim will be our primary contact from now on. Duboff announced a project coming up on the weekend, Soldiers' Angels, in which donated supplies will be collected for injured troops receiving care in Germany.

She reported that Harman originally cosponsored the Credit Card Act of 2009, HR 627, establishing fair and transparent practices relating to the extension of credit. Provisions include keeping rate increases under control and requiring parental permission, or proof of ability to maintain credit, for people under 21 to obtain a credit card.

The bill became controversial when a provision to allow loaded guns in National parks was attached. Jane then voted to oppose, but the bill has been passed into law.

As a member of the Energy & Commerce Committee, Jane authored two provisions in the American Energy Security and Independence Act, HR 2454, to enhance the efficiency of outdoor lighting and encourage the sale of "best-in-class" energy-efficient appliances.

Jenny Oropeza representative Primitivo Castro spoke about the senator's support of Sheila Kuehl's single payer health plan for California and her support for eliminating the 2/3 majority requirement. She is also sponsoring SB 4, a proposed ban on smoking at State beaches and parks.

Oropeza's Senate Bill 35, "Feed the Hungry," is an effort to decrease the amount of consumable food that is discarded after catered events. The bill calls for matching up leftover food with appropriate non-profit organizations.

The Senator is also working on an amendment to SB 425 to expand the power to issue alcohol licenses beyond the local police chief to city councils and city managers.

Tony Hale reported that the Fiesta Hermosa booth brought in about 25 new Democratic voters. Attendees stopped by to give thumbs-up and have their pictures taken beside the Obama cutout.

Assembly candidate Kate Anderson spoke

about her campaign for Ted Lieu's seat, which will be vacated in 2010.

Bobbi reported that the State Convention was a big success. John Burton is the new chairman of the California Democratic Party and Eric Bauman, vice chair. Eric Bradley did not win the Controller race. The next Convention will be in Los Angeles.

It was announced that the 53rd AD Committee meets regularly at Hennessey's on third Thursdays.

Tony announced that the DAC has expenses covered for another year and he needs more volunteers to help at the office. The DAC website has been updated and contains a calendar of events.

Dency Nelson announced an upcoming garden party for Ted Lieu and a Grey Water seminar at the Hermosa Beach Council chambers followed by an oceanfriendly gardening seminar with Ed Begley, Jr. Event updates can be found at environmentalprioritiesnetwork. wordpress.com.

Michael Keegan spoke about his concerns on AB 155. Under this provision, a municipality would have to obtain approval from the California Debt and Investment Advisory Commission before filing for bankruptcy.
