A Busy Beginning For the 2012 Election Year

We began the year at an event with Representative Henry Waxman. Mr. Waxman's current district was adjusted in the redistricting process and is now the 33rd Congressional District which includes the Beach Cities and PV. Nearly 150 Dems from the Beach Cities, El Segundo, Torrance and PV welcomed Mr. Waxman to the South Bay. He shared some insights from his years of service in Washington and then answered questions.

On Saturday, January 21, the area delegates and club representatives attended a pre-endorsement caucus and endorsed Al Muratsuchi. Al is our endorsed candidate for our new Assembly District – 66th AD.

Following that event, in the early evening, nearly 75 Democrats from our new Assembly District—including Beach Cities, Palos Verdes, Torrance, and Gardena—celebrated the Kick-Off for the

political season in 2012. Local elected officials joined us and shared insights about their cities, including Pat Furey, Torrance City Council, Bill Brand, Redondo City Council, Jeff Duclos, Hermosa City Council, and Ray Waters, Hermosa School Board.

I am just finishing writing this at the California Democratic Convention in San Diego. Governor Brown and Attorney General Kamala Harris inspired the delegates during the general sessions. Senator Dianne Feinstein and Senator Al Franken addressed the lunch and dinner sessions.

Most importantly, endorsements at the convention included a California Democratic Party endorsement for Betsy Butler. Congratulations to Betsy!

The Organization and Development Committee has assigned our application to establish a 66th ADDC for review and consideration.

As we gather momentum in this 2012 political season, building to the Primary in June and the general election in November, all of us will be needed to work together to elect Democrats, especially Al Muratsuchi for the 66th AD and Henry Waxman for 33rd Congressional District.

November Meeting Recap

Following is an edited version of the minutes from our November 16 meeting courtesy of Kathy Campbell

Treasurer's Report

Beginning Balance \$1,550 (Federal), \$373 (State)

Deposits & Transfers: \$140 (Federal) from renewals and donations Expenditures & Transfers: \$600 (Federal), \$100 for LACDP charter + \$500 donation to Al Muratsuchi's campaign for new 66th AD Ending Balance \$1,090 (Federal), \$373 (State)

Motion made, seconded and approved to accept Treasurer's report from last month.

Lisa Pinto, Legislative Director for Congressman Henry Waxman, was our November speaker. Waxman is currently the Representative for the 30th Congressional District and ranking member of the House Energy & Commerce Committee. He is expected to be the representative to the new 33rd after redistricting in the next election. Lisa has worked for Waxman for 15 years.

This is Lisa's first official visit to the future 33rd Congressional District. She oversees constituent services. They help Veterans, people with Social Security and IRS issues, and Ioan modification problems among other things. Lisa stated that Waxman is concerned that banks are not being more responsive and is looking into that. Waxman has the following facilities in his district: Santa Monica Airport, West LA Veterans Administration Center, Federal Bldg, and the Santa Suzanna Field Lab.

Waxman is the most senior Democrat on the House Energy & Commerce Committee, and was formerly Chair of the House Oversight & Reform Committee.

assumption was that the banks would mend their ways. The banks rapidly reverted to protecting their turf, slipped back to their former tactics, no changes in attitude or methods.

He has been writing letters advising the Super Committees on the budget deficit. A letter was sent regarding preserving safety nets and social programs such as Social Security, Medicare and Medicaid. He suggested a focus on innovations such as auctioning spectrums, clean energy policies, health savings and cutting fraud and abuse. He also mentioned correcting Medicare prescription drug coverage, and closing the "doughnut hole," as well as speeding generics to reduce drug costs. He is not optimistic about the Super Committee meeting their deadline of 11/23. They seem to be operating under a veil of secrecy, with little substance until recently.

Waxman is delighted with the new district lines. He has never represented the beach cities before. Anne Faas asked about extending unemployment benefits further. Lisa said that Waxman is supportive of that idea.

Lori Geittmann asked about a recent County Committee presentation on use of the VA building for commercial interests vs. Veteran housing. She says that they characterized Waxman and Feinstein as not supporting housing. Lisa says that Waxman got the President to sign legislation prohibiting the sale of the property or further commercialization, and that Feinstein did as well. Waxman asked the VA to review the leases and terminate those that are inappropriate, such as Enterprise Vehicle Rentals. He also met with others and got \$20MM dedicated to housing Veterans. Lisa says that she is sorry to hear that his position was misstated.

Tony Hale raised concern about changes to Medicare Advantage in the new year, asking whether that is part of "Obamacare"? Lisa said to call her office to speak with a specialist in that legislation for accurate information on this.

Diane Wallace asked about a Senate initiative proposed by T Boone Pickens regarding natural gas. Asked for insights on the natural gas and fracking discussion, Lisa suggested following up with Greg Dobson, the policy analyst on that issue.

Dency Nelson mentioned that he met Waxman last week and told him about Al Muratsuchi's race for the new 66th Assembly District, and said that Waxman pledged to help us in that fight.

Communications

One member asked for signatures on a petition to repeal the death penalty, which was circulated. The Party has received our charter request and list of voting members. Clark Lee from LACDP wrote to notify us that the 2012 preendorsement conference was to be held 1/21 – 22. Also, he thanked us for our work on last week's local elections. We elected progressives at every level in LA County.

Membership Committee Report

Kevin Sullivan reported that the membership party was a success. He thanked membership committee leaders Diane Wallace, Lisa Power and Lori Geittmann for putting it together. Ted Lieu attended and a lot of new faces were there. Diane mentioned that they invited a lot of local Democratic elected officials, who did not come, and are not club members. Diane plans to follow up with them.

Al Muratsuchi's race for 66th AD

Craig Huey (R) is now in the race. He apparently suggested that Nathan Mintz drop out, which he has not done. This could be good for Democrats if Republicans split their votes. In an open primary, more Republicans will turn out for the primary, which could hurt Democrats if there's only one Republican candidate for the AD.

Diane said they are planning events in PV and the Beach Cities Goal is to raise \$100k for Al by 12/31. His campaign wants to set up separate Act Blue links for each region.

Teresa Bird said that \$4k was raised at the Torrance club's fundraiser. She also mentioned that the Daily Breeze had an article about the race that day. She urged a strong focus on this race. Kevin Sullivan announced that Speaker John Perez endorsed Al this week and urged us all to contribute now to prove to the party that he can win.

Lori asked if someone is willing to host a fundraiser in their home. Dency asked if we could make the joint holiday party into a fundraiser. Diane suggested that we announce a non-event fundraiser, send out a massive mailer, just ask for donations for now, with events to follow. Kevin and Lori spoke in support of that idea. Kevin suggested forming an exploratory committee. Volunteers included Kevin, Lori and Diane. Lori asked for assistance in creating a mailing list. Kathryn Campbell offered to help set up a Google Doc for members to add their non-member friends' addresses to.

Dency said that Al is running well, attending every important event, every council meeting, and just wanted to acknowledge what a great job he's doing so far in meeting and listening to people.

New Year Party Planning

Diane Wallace said there will be a membership party in January 2012. Waxman will be around for the first few days in January and Diane is trying to work with his staff to set up a time when we can meet him. Kevin invited Lisa and his other staff to attend our party.

Report from Elected Officials

Ray Waters reported on the Hermosa Beach School Board. They have selected a new Superintendent and will announce that at their next meeting.

Diane noted that the majority of local school boards seem to be dominated by Republican men. She encouraged us to help Democrats to run for more local offices (school boards and city councils) in our district. Redondo Beach will have a Mayoral race in 2013.

Dency gave results of the Hermosa Beach election, and noted the death of John Workman days after losing his bid for re-election.

Report from Other Democratic Clubs

County Committee

Tony Hale spoke regarding some upcoming eBoard issues prior to the meeting this weekend. Asked for input regarding chartering of the Progressive Caucus, he said their charter was pulled at the last meeting by the head of the African American caucus because they sought an alternative candidate to Barack Obama. Party rules say that the caucus can only support candidates endorsed by the party. Asked for a vote, the vast majority supported the action against re-chartering the Progressives.

Changes under consideration to the Democratic convention: To save money, a proposal has been made to cut the convention to two days and either make caucuses pay for their own rooms or meet outside the convention. Tony does not support that and feels that we need that time to do our work, and it would reduce the voice of the delegates. Kathryn Campbell spoke against the idea as well, as did Marianne Tyler. Tony stated that caucuses might be asked to contribute more. There was some support for that idea.

Marc Saltzberg said that the party exists to hear from us and to elect our (Continued on page 4)

reps, and caucuses are integral to that. People are concerned about the impact of making the caucuses pay their own way. Lori stated that some caucuses are ridiculous, and called out the Irish American caucus as an example. Some have poor leadership. She suggested that the party support those leaders in becoming more effective, but also thinks that with the new fees and fundraising going on, they have the money to fund the caucuses. Marc asked if the party was short on money. Tony says we're far ahead of Republicans in state fundraising.

Marc suggested choosing hotels in off seasons (rather than Anaheim in peak summer months) to save money. He said that the party is now supporting caucus chairs more to help them become more effective. Tony called for a vote on the BCDC's opinion, and the majority voted in favor of keeping conventions at three days.

<u>New 66th AD Club Formation Committee</u> Diane Wallace announced that the exploratory group has developed bylaws and will present their request for charter at this weekend's eBoard meeting.

Also the Education caucus group that she formed was encouraged to submit as a statewide chartered organization rather than as a caucus. They plan to re-submit in that format and hope to be accepted.
