Remembering Steve Zucker . . . Politics is essentially about people. I like to think of our Democratic Party and the Beach Cities Democratic Club as organizations with good people who are serious about making things work for everyone – observing – watching for things that could be different.

This month we all experienced the sudden loss of Steve Zucker. And so, in this month, we dedicate this column to an exceptional person - our good friend, Steve.

Steve's son, Joshua, sent this brief biography:

Joel Steven "Steve" Zucker, 71, of Manhattan Beach, died February 2. He was born in Charleston, SC. Steve graduated from MIT and earned his PhD in Electrical Engineering at Stanford University.

An early pioneer in computer science, Steve worked at Fairchild, RAND, and UNIX-based startup Interactive Systems Corporation, among others, before ending his career with Sun Microsystems. In his retirement, he volunteered as a tax preparer through AARP, supported his local Democratic Club, and became a regular member of his local yoga studio.

He is survived by many who brought him joy, most especially: his loving wife Moira; his brother Lenny; his children Joshua and Danielle; and his grandchildren, Julian, Russell, and Celeste.



January Recap

1. Call to Order / Introductions

Club Vice President Mark Drabkin opened the meeting and welcomed members, guests and new members.

2. Prop 30 Impact and the State Budget – Controller John Chiang

John Chiang's title is "Controller," but a better description is "Chief Fiscal Officer." He sits on 82 Boards, and works on behalf of the people of California. John gave more information than I was able to capture, but here are some highlights: Proposition 30 provides an increase in the state income tax rates over a 7-year period of time. This tax increase will bring in \$6 Billion per year. It also includes a sales tax increase of .25 of 1% for 4 years: \$1 Billion per year.

Governor Brown just proposed a \$97.7B Budget; and the budget is creeping back up. John Chiang's job as Controller is to keep the state from going over its own fiscal cliff. In 2008-2009, CA went into recession. Between 2007 and 2010:

- 1.34M people lost their jobs
- 5.7% Unemployment in 2007 went up to 12.5% in 2010
- 600,000 jobs (less than half than those that were lost) have been recovered

John gave a very detailed overview of the 2007-2008 financial crisis in CA and in the U.S. (Bear Sterns, etc.). The Lehman bankruptcy was the largest in U.S. history. Former Governor Schwarzenegger borrowed \$22 Billion from emergency fire and earthquake funds. Our state budget consists of:

- Education 52%
- Healthcare 29%
- Prisons 10%

John is focusing on reducing health care costs: CalPERS Health Insurance is one of the largest insurance companies in the country. They make 84% in profit. John has negotiated those rates down.

He said that America runs on borrowed money. Normally what we borrow is less than what we earn. Citizens in this environment are borrowing more. Student loan debt is crippling young graduates who are trying to find jobs with a decent [living] wage.

3. Minutes of November 28 Meeting

Minutes of the November 28th meeting were approved. *Note: The Club did not meet in December due to the holidays.

4. Treasurer's Report

Edna provided the Treasurer's Report, including account totals, income and expenditures. Further details and balances will be available at the February meeting.

5. Resolutions

- 1. Gun Safety and Regulations: Ray Waters: Passed Unanimously
- UN Convention on the Elimination of All Forms of Discrimination against Women: Lori Geittman: Passed Unanimously. Tony Hale will present to County.
- 3. Restoration of the Ballona Wetlands: Dency Nelson. Moved to the February meeting.

<u>6. Report from Senator Ted Lieu's</u> Office

Veronica Zendejas presented 5 bills that Ted Lieu has introduced in the CA State Senate; SB755 from 2012 (Safety Plans on School Campuses) was reintroduced. NOTE that February 22nd is the next deadline for submitting new bills; if members have bills that they want the Senator to introduce, please get the information to him before that deadline.

7. Report from LACDP

Lori Geittman gave an overview of the very long January County meeting. Lori and Diane Wallace will submit a request for a "Fair Use" policy to allow use of public facilities once a month for meetings.

8. 66th ADDC – Approval and Membership

The paperwork for establishing the 66th ADDC was submitted and approved, and the 2012 annual report was also submitted. A bank account was opened, and Al Shadbourne, the Treasurer and Rochelle Schneider, the Secretary, have access to the account.
