President's Message

Have you no sense of decency, sir? At long last, have you left no sense of decency?

Back in 1954, during the Army– McCarthy hearings, one man could speak on moral principle and help a whole nation introspect into its own digressions. That man was only counsel for the United States Army, a Mr. Joseph N. Welch, but he stood up to the Tea Party of his day in the form of Senator Joseph McCarthy.

During that famous confrontation in the Army-McCarthy hearings, Welch uttered those words that would create a tipping point for the nation.

"Have you no sense of decency, sir? At long last, have you left no sense of decency?"

The right wing of the Republican Party has declared total war on the President of the United States and the Democratic Party. This war is beyond the pale of partisan conflict, it is a war on common sense, science and our best nature.

We have an election coming up in Hermosa Beach on Tuesday, November 5. There are three City Council



seats and three School Board seats up for grabs, representing a possible majority vote on every issue in both bodies. In my 30 years as a resident and homeowner in Hermosa Beach, there has never been, in my opinion, a more critical council and school board election.

This council and this school board will be responsible for decisions that will shape our community for decades, if not forever. There are several issues that could be cited to prove my point, but in that this is an "environmental" column, and since space is limited, let me focus on one question that was directed to the candidates at recent candidate forums. At the October 2 Hermosa Beach City Council Candidate Forum sponsored by the HB Neighborhood Association, I had the opportunity to pose to the six participating candidates a question that pretty much asked, "Do you believe that the crisis of climate change is real, and that human beings have added to that crisis, and if so, what role does our community have in trying to mitigate that crisis?" (Incumbent candidate Kit Bobko did not participate. He has consistently refused to participate in the Neighborhood Associationsponsored debates.) The answers from the candidates were, for the most part, not surprising and provide guidance for casting our ballots. The following are sound bites [snippets?] taken from their answers, combined with a bit of editorializing on my part:

Hany Fangary (DEM) – Said emphatically, yes, climate change is real, and human beings have contributed to the problem. And, yes, the community has a responsibility to provide incentives and information to help businesses and home-

owners make energy-saving decisions with their construction. Cited the Fortunatos' "Green Idea House" and the opportunity for the City of Hermosa Beach to brand the city as the "Green Idea City."

Greg Savelli (REP) – Immediately cited a recent United Nations report stating that 95% of the planet's scientists claim climate change is real. Agrees that it is probably true. Feels that the city should provide incentives for energy savings. (He at first misrepresented the "Million Rooftops" campaign - the California campaign to install rooftop solar — by calling it the "Thousand Rooftops" campaign. Apparently, it is not something that is in our former Police Chief's everyday vocabulary!) Doesn't want to "reach into people's pockets" to make this happen. Wants to encourage but not mandate or regulate. Made a joke about having to buy plastic bags to pick up dog poop now that Vons doesn't give him those bags for

Nanette Barragan (DEM) – Responded yes, and everyone has a role. City government's role is to provide bike- and pedestrian-friendly streets, bike racks, etc.; should encourage "solar paneling" on our buildings. She recognizes and acknowledged the economic wisdom of energy savings, and talked about calling upon the resource of innovators and former Green Task Force members within the community to guide us in new directions.

John Bowler (NPP) – Immediately questioned why we as a community should be "challenged" to prove our commitment to "conservationism." Says that as a beach culture we've been doing the right things far longer than anywhere and that we have been raised to do the right things toward "conservation." (Old words, old ideas — doesn't get it, in my opinion.) Went on to say that he was "pretty convinced" that climate change was real, but also added "some recent reports" show that the models showing the connection to climate change might not be "shaping up." Says that doesn't make him a "denier," but he has some questions. Made fun of what impact our little community could have by lowering our carbon footprint to zero, getting "all of our electricity from the Vetter Windmill," and said that businesses and the community shouldn't have to "justify [their] carbon footprint." Definitely would not ever mandate subsidizing energy-savings projects "for others."

Jeff Duclos (DEM) - "Sea Level Rise, Fact! Increased Storm Intensity, Fact! Coastal Subsidence, Fact!" Went on to cite the success of the Electric Vehicle Charging Stations that the city wisely installed 1 ½ years ago, and how they have brought business to downtown and have encouraged increased electric vehicle sales. Said that if the City of Hermosa Beach were to convert its vehicle fleet to electric there would be a \$60,000-per-year savings from fuel costs alone. He also said that Hermosa Beach was in the best position to "become a magnet for green businesses and greentech jobs, etc. (A clear understanding of the economic and environmental partnership!)

Carolyn Petty (REP) – Yes, re: climate change being real. But spent most of her brief reply saying how wonderful it is that, as opposed to 30 years ago, we now have an awareness of these things. Also said that buildings like our city hall that are nearing the end of their life could be replaced with "smart, environmentally sound" buildings. Finished by saying that she was "in agreement." (Vague and evasive, like most of her campaign when confronting the general public and not her conservative base.)

I warned you about the editorializing, right? My prerogative as the owner of this column, but more importantly, as someone who is attending all of the candidate forums and who has interviewed neighbors who have been approached by the candidates. I am getting a pretty clear picture that my early selections, and our endorsement, of the three Democrats in this race are the correct ones. Same goes for the two Democrats in our Hermosa Beach School Board race. If you live in Hermosa Beach, vote for the following. If

September Recap

President Tony Hale introduced the officers and welcomed new guests. He shared a letter from Congressman Henry Waxman congratulating this term's officers of the BCDC.

President's Report

Tony opened with a recap on the minimum wage issue. The U.S. has among the lowest minimum wages among major industrialized countries, and has experienced a loss in purchasing power over time. Governor Brown just signed legislation increasing the minimum wage in California to \$10 by 2016.

Tony also mentioned attempts in Congress to limit access to healthcare through the Affordable Care Act.

Vice President's Report

VP Dency Nelson reminded us of the important Hermosa Beach city council and school board elections coming up on November 5. We have three Democrats running for city council and two Democrats running for school board, including Mary Campbell, newly registered as a Democrat. Let's defeat Kit Bobko, keep Jeff Duclos, and elect Nannette Barragan and Hany Fangary!

Dency also expressed his disappointment regarding the passage of SB4, Fran Pavley's bill, and asked that we read his fuller evaluation in his Beach Cities Green column in our September newsletter (http://www.lafn.org/politics/bcdc/bcdc2013-09.pdf).

Treasurer's Report

Edna Murphy reported the following activity:

Federal account: starting balance of \$1698 + \$50 (2 new memberships) = ending balance of \$1748.

Mary Campbell, Candidate for Hermosa Beach School Board

Mary introduced herself to the attendees and stated that she has spent her 25-year career in education. She's a former teacher who became an administrator. Mary works at USC, helping to support recruiting and staff professional development. She has two Masters degrees (Psychology and Organizational Psychology), and a Doctorate in Organizational Psychology. She also teaches leadership classes and is "passionate" about developing a 21st Century Curriculum, one example of which is the Common Core State Standards. She is interested in fostering critical thinking and innovative fundraising to support schools and education.



Ken Petrulis, an attorney and longtime member, gave an informative presentation on the Rule of Law at our September meeting.

While she was formerly a Decline to State and only recently registered as a Democrat, Mary worked to support President Obama and considers herself "wildly liberal." She favors marriage equality and immigration reform. She is against oil drilling in Hermosa, and helped found "Keep Hermosa Hermosa."

A motion was made and seconded to endorse Mary Campbell and passed unanimously.

Program: The Rule of Law

Ken Petrulis spoke on the importance of the rule of law and its role in our democracy. In Ken's opinion, the rule of law is what makes America exceptional. In Marbury vs. Madison in 1803, Supreme Court Justice Marshall ruled against President Thomas Jefferson, proving early in our history that no one is above the law. Independent judicial review is key. The rule of law is a process with five essential elements: fair access, fair courts, fair laws, fair administration, and subjecting everyone, including the president, to the law.

Ken discussed specifics of the Trayvon Martin case, in which evidence was not
