PRESIDENT'S MESSAGE By Tony Hale

California Democratic State Convention



Our state party convention was the $7^{\text{th}},\,8^{\text{th}}$ and 9^{th} of March.

Many of our club members are delegates to the party, but for those who did not attend; I will give a short report here.

The state convention is a yearly business meeting for our state party and is part of how the party creates its rules, defines its core beliefs and makes its endorsements. For business that can't be done during the yearly convention, there are two to three Executive Board meetings a year.

This year's convention was a platform convention; that means that we pass the platform for our party and do not consider resolutions at that convention. California's Democratic platform is important because it is used as a template for our nation platform.

Two notable additions to this year's platform were the support for universal pre-school for 4 year old children and support for the legalization of marijuana. Not that those two go together.

State wide candidates were endorsed for re-election except in the two contested

races for State Controller and Secretary of State. Here are those endorsements:

Governor Edmund G. "Jerry" Brown Lieutenant Governor Gavin Newsom Attorney General Kamala D. Harris Treasurer John Chiang Insurance Commissioner Dave Jones Supt. of Public Instruction Tom Torlakson Board of Equalization District 1 Chris R. Parker District 2 Fiona Ma District 3 Jerome E. Ho

For our local races we endorsed Al Muratsuchi for State Assembly District 66 and Ted Lieu for Congressional District 33.

No one was able to win the endorsement for Senate District 26. Betsy Butler came within a few votes of winning the required 60 percent needed to get the endorsement. The remaining votes were split largely between Ben Allen, Santa Monica School Board member, and noendorsement.

Two propositions that will appear on June ballot were endorsed at the convention: Prop. 41, Veterans Housing and Homeless Prevention Bond Act of 2014 and Prop. 42. Public Records. Open Meetings. State Reimbursement to Local Agencies. Prop. 42 Requires local government compliance with laws providing for public access to local government body meetings and records of government officials. Eliminates reimbursement for costs of compliance. A yes vote on prop. 42 would result in the state not being required to pay local governments for costs to follow state laws that give the public access to local government information. This new law will cement in the Constitution the public's right to know what the government is doing and how it is doing it. Local agencies shouldn't be allowed to deny a request for public information or slam a meeting door shut based on cost.

One moment of controversy at the convention was a protest of Governor Jerry Brown's speech before the convention on Saturday's general session. Some 100 delegates shouted and held up signs in opposition to Hydraulic Fracturing (or Fracking), a method of oil and gas extraction that has a higher carbon footprint than other conventional methods of oil and gas drilling.

Jerry Brown has said that Fracking could play a role in our efforts to gain oil independence and increase revenue for our state.

"You can be sure that everything that needs to be done to fight climate change that we can accomplish, we'll do it," Brown responded back to the protesters. "And I ask all of you, every one of you in this room, to join in a crusade to protect our climate, to find other ways of mobility, and to make sure this California dream is alive and well both now and for generations to come."

Obviously frustrated with single issue protest, Brown ended his speech with "Thanks a lot, and keep protesting, but add a bunch of more stuff."

Officer Reports

President's Report

Tony discussed the fact that many Dems we know are now running against each other for the same office. He reminded us not to get divided, because in the end we have to all come together.

VP Report

Dency Nelson brought a copy of the draft Environmental Impact Report for Hermosa Drilling, which was about 3 inches thick. Dency also mentioned that Ted Lieu was given the top rating for 2013 by the California Environmental Justice Alliance, in part because of his vote against AB327, "Electrical Rate Reform," which purported to support solar power, but was in Dency's opinion really a break for energy companies at the expense of rate payers. That was a difficult vote in which Sen. Lieu listened to input from South Bay environmental activists, including Dency.

[Secretary's note: the EIR 60 day comment period will end April 14, 2014, according to the Minutes of the City Council's 2/25 board meeting.]

Secretary's Report

Kathryn Campbell submitted minutes from the January meeting, which were approved.

Treasurer's Report Edna Murphy reported the following activity through 1/31/14:

Federal account: starting balance of \$1,851 + 662 in revenues - 100 for

expenses during the month, for an ending balance of \$2,413.

State account: starting balance of \$48 + 55 - \$15 (bank fees) = ending balance of \$88.

Members contributed \$600 for the John Chiang event, despite only committing to \$400. Ray Waters made a motion to also donate \$100 from the club, seconded by Teresa Bird. Motion passed unanimously. Treasurer's Report was approved.

Report from Sen Lieu's office Veronica Zendejas from Sen. Lieu's office provided a report. Friday was the deadline to introduce new bills. Some of Sen. Lieu's bills include:

SB 1388, "Human Trafficking," to protect children from sexual exploitation & slavery;

SB 115, "Geological hazards," to prevent construction on seismic fissures SB1432, "Arts Counil Grants," to restore funding to the CA Arts Council SB828, "Privacy," to ban mass spying on citizens by the Federal Government.

Sen. Lieu recently held a seniors event at the Joslyn Center to increase awareness of scams targeting seniors. They are planning another one in May in Venice.

Ted also won the pre-endorsement vote for Congressional District 33 by more than the required 70% threshold! Dency made a motion that the Beach Cities Democrats endorse him. The motion was seconded and passed unanimously.

First idea: more conservation! The single biggest thing you can do is to plant a drought tolerant yard. The WBWD offers gardening classes on those.

Don passed out maps of the CA water supply system & the WBWD.

2013 was the driest year on record in 113 years. Oct – Jan this year was the driest on record, and there could be another record for 2014. Allocation we receive from the California aqueduct is currently 0! Our reservoirs are dropping rapidly, many are below 50% of capacity. Precipitation for the last 24 months is 25% or less of usual rainfall.

The MWD made investments over the last 20 years that are helping us avoid rationing this year and next. On Jan 17, the Governor requested we reduce usage by 20%. We have done well with conservation, and as a result our usage has stayed the same over the last 20 years despite population growth. One example is the use of sewage water treated by Hyperion for commercial purposes for

non-potable water.

The Redondo Beach ocean desalinization demonstration facility shows we have the scientific understanding to implement desalinization, but it's very expensive compared to today's costs for water, and usually has to be built adjacent to a power plant. (http://www.westbasin.org/ water-reliability-2020/ocean-waterdesalination/overview). On the other hand, the Central Valley farms are experimenting successfully with solar desalinization of brackish water, which is a lot less salty than sea water, so a lot easier.

There was further discussion of various upcoming water bills, as well as the dangers to the water supply associated with fracking.

Campaigns

There are 165 judges up for election in LA County this year, with 14 open judicial positions. Five judicial candidates appeared at the meeting to present their credentials. They included:

• Marc A. Gibbons, Defense Attorney, for Superior Court Judge Seat 138. (www. marcgibbonsforjudge.com) Note: when asked to confirm that all judges asking for endorsement were registered Democrats, Marc stated that he is an independent (NPP).

• Helen Kim, Deputy District Attorney, for Superior Court Judge. (www.helenkimfor judge.com).

• Amy Carter, Deputy District Attorney, for LA County Superior Court Judge. (www.amycarterforjudge.com)

• Songhai Armstead, City Attorney, for LA County Superior Court Judge Seat 97. (www.armsteadforjudge.com).

• Andrew Stein, Defense attorney, for LA County Superior Court Judge Seat 87. (www.steinforjudge.com).

Not in attendance, but represented were: • Shannon Knight, for LA County Superior Court Judge Seat 54. (Shannonknightforjudge.com) • Debra Losnick, also running for LA

Tony noted that filing has not yet closed for these positions, although the Declaration of Intents were due. LA County also hasn't yet done endorsements. So, rather than endorse at this meeting, Tony suggested that we have another event in the future specifically around judicial nominees so we can meet more candidates and the candidates can meet more Dems. Ray Waters made a motion that we not endorse tonight, which was seconded and passed.
