

**APRIL RECAP****Beach Cities Democrats***Minutes courtesy of Kathryn Campbell***Welcome**

President Tony Hale welcomed new members and guests.

**Officer Reports***President's Report*

Tony congratulated President Obama on the enrollment success of the Affordable Care Act. He acknowledged that many Progressives are still upset about not having a single payer plan. But ACA is proving to be affordable, and is already helping many people.

Tony also thanked Al Muratsuchi, who has proposed AB 2711, which would provide a \$17.5 million loan to allow the city of Hermosa Beach to make an independent choice about oil drilling without worrying about bankrupting the city. The majority of Hermosa Beach residents oppose drilling, but many have been concerned about the cost of not allowing it (~\$17 million due to how the prior lawsuit was settled). This will make their choice much easier.

Motion made, seconded and passed to accept the agenda.

*VP Report*

Dency mentioned that we have copies of the old and new Bylaws for the upcoming discussion. Asked how many people are on the Beach Cities Yahoo Group. About half of the attendees were.

Dency ran through a list of anti-fracking initiatives including Holly Mitchell's Anti-Fracking bill and Beverly Hills passing a moratorium on fracking and wastewater injection.

Dency reminded members that the BCD sent a letter in support of Sen.

Lieu's bill to submit an advisory question to CA voters relating to campaign finance and overturning Citizen's United, and a petition is circulating in support of that.

*Secretary's Report*

Kathryn Campbell read aloud a letter from Alyse Laemmle thanking the club for keeping her apprised of club activities and supporting the proposed bylaw changes. Kathryn thanked Alyse for her many years of club support.

Kathryn submitted minutes from the March meeting. Motion made and passed unanimously to accept minutes from March meeting.

*Treasurer's Report*

Edna Murphy reported the following activity through 3/31/14:

Federal account: starting balance of \$2,438+ \$590 in new membership and renewal revenues - \$120 in charitable donations to the 1736 House Family Crisis Center, for an ending balance of \$2,908.

State account: starting balance of \$63 + \$155 in new membership and renewal revenues - \$100 contribution to John Chiang for Treasurer campaign \$15 in bank fees = ending balance of \$103.

Edna mentioned that we received Thank You notes for our contributions to 1736 House and Jim Buescher's memorial fund. Motion made and passed unanimously to accept Treasurer's Report.

**Program: Jeff Duclos, Climate Reality Project Training**

Jeff Duclos made a very interesting presentation on his recent training with the Al Gore Climate Reality training, which he had to apply for and was accepted to take recently in South Africa. Al Gore has been talking about climate

change for 40 years! Since 2007 he has trained over 3,000 people globally to be climate change speakers. Jeff called on each of us to become vocal on the issue, and to focus on what we can still do to help.

- Change laws, not just light bulbs! Let your electeds know that this matters to you.

**Bylaws review**

After reviews and revisions lasting several years and multiple eBoards, proposed bylaws have been submitted for review and discussion. Tony stated that the proposed bylaws are clearer, more modern, and more refined than the existing bylaws, which had undergone only minimal revision in 20 years.

Discussion points:

- Ray Waters asked about the four board members listed, as opposed to the existing bylaws that included immediate past president, recording secretary, and committee chairs.
- Motion made to add standing Committee Chairs and immediate Past President to the Board of Directors. Passed with one abstention.

There was some discussion as to whether we should hold the bylaws discussion for a future meeting at which more time could be allotted given the fact that the meeting was running late. However, Dency reminded everyone that the bylaws discussion has been kicked down the road for many years, and all members were given two weeks prior to the meeting to review and come prepared to raise questions. Ultimately a motion was made to adopt the proposed bylaws with the above amendment made, which was seconded and passed. Tony closed by saying that additional changes may always be made in the future and invited members to review the bylaws and raise potential issues and suggested changes at any time.

Reports from Local Electeds

*Don Dear, West Basin Municipal Water District Board Rep*

The West Basin Municipal Water District Board voted to raise Metropolitan Water District rates 1.5% per year for the next two years to support upkeep on our water system. Don recently conducted an educational tour of the Parker Dam. Don is opening up his tour on May 22, a one day trip to Edmonston Pumping Station in Tehachapi. Jeff DuClos, Appointed Alternate to the California Coastal Commission. Approved local coastal program for the Santa Monica mountains, the largest coastal area that was unprotected. They plan to take up desalinization next.

66<sup>th</sup> Assembly District Democratic Council Report

Lisa Power announced that the next meeting of the 66<sup>th</sup> ADDC will be tomorrow night, on April 24<sup>th</sup> at the Sizzler in Torrance. Will hold a quarterly meeting and discuss upcoming ballot resolutions. May include candidate speeches as well.

Old Business, New Business

Tony asked for volunteers to serve on the Nominating Committee for next year's officers. Ray Waters offered to serve as Chair, and Teresa Bird, Anne Faas and Dency Nelson volunteered to serve as well.

Ray Waters asked for a motion to support SB1381, regarding labeling genetically engineered ingredients in foods. It was introduced by Senator Noreen Evans and is now in Senate Committee. Don made a motion to amend to also send letters in support to Ted and Al. Motion passed.
