On this final meeting of 2017, President
Bobbi welcomed members and
newcomers. She reminded the group
that our most important push must be to
take back Congress in 2018. There are
five seats in Southern California alone,
and seven--possibly nine--in the state
overall.

She mentioned the president's frequent anti-Muslim tweets along with the many outrageous messages coming from the White House, and said we must do everything in our power to defeat the upcoming tax bill. Call your members of Congress, using the handout we have at every meeting which lists all contact information, in addition to prominent resistance groups. Call, fax, email--do whatever you can to get the message across.

Vice-President Dency Nelson thanked the club for its endorsement of the three Hermosa Beach City Council candidates, all of whom were elected. We now have five progressive Democrats on the Council. Supervisor Janice Hahn attended the swearing-in ceremony, as did the representatives for our elected officials.

He said the draft EIR for the rebuilding of Hermosa North School was completed, and it proposes to be a net-zero energy building. There is some controversy related to increased traffic as parents drive their kids to school. This is a valid issue, but Hermosa is a small city, and such issues are inevitable.

Reports from Electeds

Joey Apodaca reported from Ted Lieu's office, saying that the Congressman is committed to opposing a war with North Korea. There are "no good options," and Ted is working with 16 other Congressmen to investigate the cost of a war with North Korea. The Joint Chiefs of Staff have said that the only way to avoid a nuclear threat is a ground invasion, but that invasion could involve the use of chemical and biological weapons.

Ted is hoping to invoke the War Powers Act, which would require the president to get authorization from Congress. His bill, H.R. 669, is entitled "Restricting First Use of Nuclear Weapons Act of 2017."

This bill prohibits the President from using the Armed Forces to conduct a first-use nuclear strike unless such strike is conducted pursuant to a congressional declaration of war expressly authorizing such strike.

Concerns that a president could order a preemptive nuclear strike are on the rise in Congress as President Trump continues to trade insults with North Korean dictator Kim Jong Un. For the first time in more than four decades, the president's powers to call up the nation's nuclear arsenal were the subject of a congressional hearing.

"I applaud Senators Corker and Cardin for working together to evaluate presidential authority to use nuclear weapons," reads Ted's website. "Launching a weapon that can kill millions of people instantly in a nuclear first strike is an indisputable act of war. I'll say what I've been saying for some time: Only Congress has the authority to declare war."

Regarding the Russia investigation, Joey said that the president has not signed off on sanctions, and his intentional lies on the subject may constitute obstruction of justice.

He mentioned the four American soldiers who were killed in Niger, and that the U.S. still doesn't know the facts. Senator John McCain agrees that this should be investigated.

On the war against ISIS, the Congressman wants to know how many civilians were killed in Operation Inherent Resolve; the number has skyrocketed since Trump took office.


Joey then turned to the upcoming vote on tax reform, which Ted has termed "terrible, despicable, and absurd." California stands to be the biggest loser, with an estimated \$12.1 billion in tax increases which will fall on the middle class and below, and be a huge giveaway to the wealthiest Americans.

As for the Clean Power Plan, Congressman Lieu issued the following statement on Environmental Protection
Agency Administrator Scott Pruitt's decision to repeal the Clean Power Plan.

"The EPA is supposed to protect the environment, but Administrator Pruitt is undermining the Agency's mission by putting the interests of his friends in the fossil fuel industry before those of the American public. The Trump Administration can pretend that coal can be a viable industry again but their hollow words are just a distraction from efforts to actually assist coal miners searching for work. The coal industry is declining not because of the Clean Power Plan, but as a result of market forces."

Next we heard from Redondo Beach City Councilman John Gran. The city is hoping to purchase the site of the AES Power Plant, with the idea of preserving parkland and restoring wetlands on the open space component. The rest would be built up by a private developer, which could entail a hotel, restaurants, shops or other mixed-use development. The plan may or may not include housing.

Gran spoke about Community Choice Aggregation. This was authorized in California under AB 117 and SB 790, and allows local governments including counties and cities to purchase electricity in

the wholesale power market and sell it to their consumers at competitive rates, as an alternative to that purchased by Southern California Edison. SCE would continue to deliver electricity, maintain infrastructure, and bill consumers.

Regarding the Galleria update, it is now in the EIR process. It's hoped that the expanded Green Line will build a stop next to the Target store next to that property.

As for the Artesia corridor, the city is hoping the site of the former Haagen grocery store may become a grocery outlet, which would greatly improve the look of the boulevard. The Artesia overhaul project is seeking input from residents as it goes forward.

He discussed a proposed bike sharing program, which could make a positive environmental difference, but could also put local bicycle shop owners out of business. Dency commented that there are pros and cons to this proposal, the bicycle shops being long-established businesses in the small city of Hermosa Beach.

Melissa Ramoso, Al Muratsuchi's District Director, spoke next. She opened by thanking our club for our endorsement. She spoke about the important California

Disclose Act, of which Al is a co-author. It requires the names of large donors to be disclosed in political advertising.

The Torrance Refinery has been a big issue since the dangerous explosion last year. Residents in the area want to ban the use of Modified Hydrofluoric Acid (MHF). This modified version of the otherwise banned chemical is still very dangerous and is stored in tanks near where the 2015 explosion occurred. Even a minor release of MHF could have drastic effects on the surrounding community, including severe injury and death.

Three bills have already been signed, which would:

- 1 Install air quality monitors in surrounding neighborhoods;
- 2 Require refineries to pay for and install community alert systems; and
- 3 Set up an inter-agency task force on refinery safety, to coordinate safety efforts.

She said that the president is trying to restore offshore oil drilling, an issue that the Assembly is taking seriously. The

other big issue is single payer health care, SB 562, "Healthy California." Al thinks this would be better handled at the national level.

Towards the end of the meeting, Al came in to greet the club—having just left an earlier meeting—and thank us for all our support. He reiterated the need to work together to defeat his opponent.

A club member brought up the question of rent control, in the wake of the Ellis Act, a California state law that allows landlords to evict residential tenants in order to "go out of the rental business," in spite of desires by local governments to compel them to continue providing housing. The shortage of affordable housing in California is a serious problem. Al thinks there is not an incentive to build more homes, especially in the beach cities communities, because of density. There are pros and cons to this issue, and a lively discussion followed.

As a reminder, Al's election is coming up again next year. Dency reminded us that when people vote, Democrats win,

and Al's loss in the 2014 election was due to low voter turnout. We need to launch a serious campaign, especially since his opponent next year is Frank Scotto, a Trump Republican. This district has a 10% Democratic advantage--so it's all the more important to get out the vote.

Tony Hale reported good news from the Executive Board meeting of the California Party held in Millbrae on the 17th. 18th and 19th of November. There was a renewed sense of unity in the party and a clear example of new leadership. The conflict over the race for the chair's position seems to have passed, and the process for that election was one of the most transparent and accountable procedures our party has ever exercised to guarantee the validity of an election. At that meeting, there was a focus on Asian Pacific Islander issues since Millbrae has one of the most densely populated concentrations of that group.
