January Recap

On January 24, BCD cancelled our regular meeting to attend Representative Ted Lieu's appearance at Torrance's Toyota Meeting Hall. The well-organized event was held jointly by various Indivisible groups in the area, and the audience was enthusiastic, greeting many of Lieu's statements with cheers.

"I don't get that kind of applause in Washington D.C.," he said.

Mark Drabkin noted that Indivisible did a great job with security, specifically with keeping out the hecklers/disrupters who frequently get into events like this one. He wrote, "On this occasion Ted was able to speak without anybody yelling 'LIAR' or anything like that." Mark also sends props to our local Indivisible chapter leaders who spearheaded the effort to organize this event including, but certainly not limited to, Mary McCulley, Umesh & Lori Ketkar, as well as our own Rochelle Schneider."

Lieu began by addressing the recent federal government shutdown and explained why he voted against the Continuing Resolution to fund the government.

"It's not only harmful to the military, there was no fix for DREAMers, it did











nothing to address community health centers – it was missing a lot of things," Lieu said.

He also addressed the ongoing investigation into alleged Russian meddling in the 2016 Presidential election, and President Trump's actions surrounding the investigation, including the firing of James Comey.

"We have confirmation that the Special Council is looking into obstruction of justice...if you remember Watergate, Nixon ended up resigning for obstruction of justice and obstruction of the investigation. That was the first Article of Impeachment that the House Judiciary Committee passed out," Lieu said. "Here's a fun fact: I sit on the House Judiciary Committee."

The Congressman also spoke about the upcoming 2018 elections, including targeted districts that Democrats hope to win from Republicans, including those of retiring Republican Congressmen Ed Royce and Darrell Issa. When asked about 2020, he cautioned activists to not look too far down the road. He said, "I think the time to look toward 2020 isn't now, but in December 2018."

When asked about recentlyannounced federal tariffs on foreign-made solar panels, Lieu said the tariffs were "a stupid thing to do" that would have a negative effect on small businesses that purchase and use solar panels.

In appearances elsewhere, Congressman Lieu has predicted that more indictments are coming this year in special counsel Robert Mueller's probe. It was reported in the *New York Times* that Mueller's investigation began because former Trump campaign adviser George Papadopolous told an Australian diplomat that Russian officials were peddling information damaging to Hillary Clinton. "We know that George Papadopolous has now agreed to cooperate with special counsel Mueller," Lieu said on MSNBC.

He added that the revelation about Papadopolous "leads to all sorts of questions such as who else on Trump's campaign knew, what did the Trump campaign do with this information."

Criticism from Republicans has not stopped Lieu from defending Mueller and his probe, and continuing to criticize Trump and his administration, including son-in-law Jared Kushner. One of Ted's favorite questions is, "Why does Jared Kushner still have a security clearance?"

In a recent email statement, Lieu said:

"The truth is Russia interfered with our election and multiple members of the Trump campaign have pled guilty as part of the investigation that's trying to determine if the Trump camp helped Russia. The truth is Trump has obstructed justice and does things an innocent person just wouldn't do. And the truth is that this White House is full of people who lack proper security clearance, including Jared Kushner."


warrant as well as the response from the Democratic members of the House Intelligence Committee that the majority to date has refused to release. Lieu spoke in measured, even tones, without a lot of rhetorical flourishes.

The Congressman said he didn't think the Republicans would be able to control the narrative once the public had the opportunity to read both memos in their entirety, including the material factual information which Nunes deliberately omitted in an attempt to tarnish the FBI and the federal investigators.

He also expressed his strong concern about Trump's projected strategy to administer a so-called "bloody nose" to North Korean dictator Kim Jong Un. Lieu, who still is a member of the Air Force Reserves, talked about his personal experience in participating in military exercises aimed at North Korea while stationed in Guam. In Lieu's view, such a preemptive strike would be highly reckless and counterproductive, given the U.S.'s poor military intelligence on North Korea, North Korea's proximity to heavily populated areas of South Korea, and North Korea's stockpile of chemical and biological weapons.

Lieu said that he supported the same merit-based immigration system that permitted Donald Trump's 16-year-old grandfather to legally migrate to the U.S. on a steerage class ticket with limited English skills and few economic resources.

In response to a question about his top infrastructure priorities, Lieu listed the light rail extension to Torrance as his #1 priority, along with increased investments in cybersecurity.
