December Recap

Tony Hale called the meeting to order, since our President, who was newly elected to the Hermosa Beach City Council, had to attend a special city council meeting. Tony asked for new members and there was one. He welcomed everyone and said this was the ground floor of the Democratic Party. He asked Assemblyman Al Muratsuchi to lead us in the Pledge of Allegiance.

Tony mentioned that the impeachment hearings have been interesting and illuminating. He then gave the Treasurer's Report, since Edna was absent:

Federal PAC \$2.065 State PAC \$5,185

Andrea Valcourt reported that with the new voting system, the county is looking for people to work at the voting centers. More people are needed, since the polling centers will be open for eleven days, including election day. However, people can still vote by mail. Tony added that there will be a bar code on the ballot. so you can vote using your cell phone. Andrea stated that the bar code is equal to your precinct number and no personal information is attached. See LAvote.net for details.


Editor's note: The county is paying \$100 per day to people working the polling centers.

Tony gave the State Party Convention report: There are several segments in the party, but we need to work together. Some were opposed to the Israel plank in the platform. This year was unique because we had two conventions. This one was covered by Univision. It was a good convention and we got a lot accomplished. We worked on rules. Our job is to make the party more open and to keep improving it. We have amazing representation in our state and it was good to hear from our electeds. We are a good example for the nation.

Al Muratsuchi gave an update and took questions.

Al said he has the privilege of

representing the South Bay. Things are going well for California, which has the 5th largest economy in the world. The state is fighting the climate crisis and we are the most aggressive in the U.S. and the world. We showed we can grow our economy with green jobs, while fighting climate change.



AB 1482 protects renters from landlords who indiscriminately increase rents. It is not a rent control bill.

Another problem the state faces is the wildfires and the related electricity outages. We've been lucky here to not have these outages. It is a reflection of climate change. PG&E has taken preventive measures with planned outages. It is a very extreme measure and affects seniors and their medical equipment the most, PG&E must find a solution as it goes through its bankruptcy proceedings.

AB 342 protects our lands from Trump's oil drilling policies in our national parks. We don't have jurisdiction on federal land, but we can prevent the required equipment from going onto state land. It's not a perfect solution, but it is what we can do. It is similar to the bill that prevents oil drilling equipment in our local waters and on our shores.

Al is co-sponsoring a plastics bill with State Senator Ben Allen. It will reduce single use plastics. They're hoping to get it passed this year.

SB 50 is a senate bill to override city and

county zoning laws to help eliminate homelessness by increasing housing units, but it also can increase density. Communities don't want more building, especially here in the South Bay, where we are pretty densely populated and traffic is awful. Al believes we should not fix housing by the state overriding cities and counties.

SB 50 proponents believe it would provide more housing next to transit hubs. Al thinks they should be built around job centers. This would be good for reducing vehicle pollution. It was noted by an audience member that we should build more transportation options before we build more housing.

Another person stated there are new condos on PCH, which are not selling because they are too expensive and they are on PCH. Could the state encourage builders to make these types of development low rent with incentives? Al said he would see if there is such a SB 50 provision and get back to the gentleman.

Near San Francisco, in Palo Alto, the schools are helping teachers get housing. There are also measures to build more college housing such as March Ballot Measure 13, which is a bond to pay for this. 25% of students do not have reliable housing and affordable housing is a bigger problem for them than tuition.

A person asked if modular housing could be a solution. Al remarked that he got a 75 page proposal from a homeless man and it was well thought out. It was noted that in Japan they have pods,

which have a bedroom and common area for recreation and bathrooms. They are small, but very inexpensive to rent.

Another member asked about the rising pension costs. Al said that a 2012 bill did have some controls in place for those hired after 2012.

Tony then said asked the candidates to speak before we voted on endorsements.

Al stated he was running for his 4th term and would like to be endorsed by the club. He wants to keep fighting for the South Bay and add to the good things already accomplished. Tony stated that the only other candidate is Arthur Schaper, who some say is a White Nationalist. The motion to endorse passed unanimously.

Linda Sun, running for Judge Seat 42 Linda said she is a 1st generation immigrant. Her parents were teachers in Hong Kong. She came to this country at age 18 and stayed. She said "March Fong Eu inspired me to go to law school. I worked to pay for college and to bring my parents here. I became a Democrat. I did pro bono work and then became permanent Deputy Attorney General and prosecuted over 1,000 cases against unscrupulous business people. I was promoted to supervisor and have a team that adjudicated the most cases in the shortest time. It is a very efficient team. No one is above the law and no one can abuse the law. Many electeds have endorsed me."

Tony said that he couldn't determine if her opponent is a Democrat. However, he did not respond to Tony's emails. The motion to endorse passed unanimously.

Emily Cole, running for Judge Seat 76
Emily said she was born in LA and went to college and law school in San Francisco. She has been a Deputy District Attorney for 12 years and has been in most of the LA County courtrooms. She said, "I was able to meet the people and get to know our diverse communities. I focus on elder abuse cases and sex crimes. I'm passionate about representing these vulnerable victims and try to make the process easier for them. I have a

100% conviction rate. I've been able to get help for drug and mental health defendants by being an advocate for them."

Judges do so much in people's lives: set bail, decide traffic tickets, decide if defendants go to jail or not. Be sure that the judges you vote for have the right qualifications." I will keep a tight calendar and will keep cases moving. My opponent has been a Democrat for two years, but was a Republican before that. He legally changed his name to Judge Mike Cummings for political and business reasons and lives in San Luis Obispo." The motion to endorse passed unanimously.

Tony said there is a fund raiser for Al at Smog City. Also, please refer to our agenda for other announcements. He then moved on to our January fund raising party. Ray Waters offered their house again on January 18. The motion to accept the date and place passed unanimously.
